WVAD Delegates Share Experience By: John Burdette & Jimmy Harrison

President John Burdette and Treasurer Jimmy Harrison attended the 47th biennial National Association of the Deaf Conference held in Kansas City, Missouri. Secretary Liz Leisure made herself available as alternate delegate when needed. There were more than 1,500 participants. The conference theme was "Eye for the Future", paving the way for participants to start a plan for NAD's future. NAD kicked off the conference with a Kansas City style barbecue and a show, The Wizard of Oz.

The NAD Board of Directors has started the long term strategic planning efforts called Fulton III (F3). The NAD Board of Directors appointed Steve Florio of Rhode Island as Chair of F3, along with Barbara Jean Wood of Colorado vice Chair.

In case you were wondering why NAD called it "F3", the original Fulton Conference was held in Fulton, MO in 1957. Next was the "Fulton Revisited" in Phoenix, AZ in 1987. Now with "F3" Restructuring Process, they will work on more structured more detailed and more intensive process over the next two years that will involve state associations and organizational affiliates, and national members as well as prospective members. President Burdette attended the State Association President Dinner, where we as the Presidents had the opportunity to listen to testimonies from several other State Associations on their successes over the past two years. Many states have similar issues with recruiting new members, lack of communication from the prior administration and officers having no training regarding leadership and accountability. The Association Presidents and NAD Board of Directors discussed and agreed to commit to work together by increasing the communication channels between the states and NAD Board of Directors and NAD Headquarters. It was agreed that the Presidents will have a State Association Presidents Retreat to be held in the spring of 2005 in Florida.

Gallaudet University took home the College Bowl championship after defeating CSUN and NTID/RIT.

One of the most exciting events of NAD Conference was the Miss Deaf America Pageant, including our Miss Deaf West Virginia, Linda Phillips, participated along with 25 other women. She didn't make it in the final six, but she definitely learned so much during the two week long events. Overall I had a great time and I look forward to sharing my experience with you at the WVAD conference in August 2005.



In its 10th year, this year's event was held at Yogi Bear's Jellystone Park Camp-Resort. Activities at the event included logging, ax throwing, horseshoes, volleyball, and outdoor activities for adults and children.

Participants filled some 900 area hotel rooms and as many as four area campgrounds. It's the largest gathering of deaf and hard-of-hearing people in the world, organizers said.

WVSD Teacher Retires

The June 11, 2004 graduation ceremony at the West Virginia School for the Deaf (WVSD) was a significant day for graduating seniors but it was also a significant day for Pierre Sevigny. It was his retirement day.

Sevigny was born on October 27, 1938 in Beaupre, Quebec, Canada. He was born deaf and was given the opportunity to study French Sign Language or American Sign Language. As he observed the two, he decided on ASL because it had more to offer. Finishing his required education and wanting more, he entered Gallaudet University where he studied to become an educator. In 1961, following graduation, Jack Bradley (Superintendent of WVSD) offered him a job. This is the place he would call his home.

He met his wife, Christie, in Romney and they are proud parents of three children, Forrest, Hayley, and Christopher. Hayley, a graduate of WVU, went to Gallaudet and entered into the Interpreters Program.

Sevigny accomplished many things during his tenure at WVSD. He worked to have school employees paid on a 12 month plan instead of a 10 month plan and he started the pre-vocational program for elementary students teaching them building and repairing skills. He also integrated the students from WVSD into Hampshire High School athletics. He was a coach for football and track and field and he is still the coach for the disc throw at Hampshire High.

Sevigny plans to travel and spend more time woodworking, his favorite hobby. He is looking forward to a new grandchild as well.



The West Virginia Association of the Deaf meeting was called to order by President John Burdette in the Alderson Community Center, Chestnut Street, Alderson, WV at 1:25 p.m., on May 8, 2004.

The minutes from March 13, 2004 meeting were read and approved as corrected.

President's Report:

President Burdette announced that the WV Commission for the Deaf and Hard of Hearing (WVCDHH) published its newsletter named "Signing Times" via e-mail. If requested, we can receive a printed version of the newsletter. It was interesting to notice that nothing was published about the WVAD picnic.

President Burdette announced that the WVCDHH scheduled a preparation workshop for the certified Deaf Interpreters at South Charleston Library to be held on June 4, and 5, 2004.

President Burdette reported that Liz Leisure received an e-mail from Terry Pickett who is a colleague of Tim Murphy, Attorney for the West Virginia Advocates, wanting updates on the installations of new TTYs in rest areas. President Burdette asked that we check the rest areas to see if any TTYs are installed or not and let know Liz by Monday so that she may report to Ms. Pickett.

President Burdette reported that he and Treasurer Jimmy Harrison received new business debit cards from BB&T.

President Burdette talked about getting a credit card machine. He was debating on whether to rent or buy one.

The deaf girl from the West Virginia School for the Deaf (WVSD) that wanted to attend the National Association of the Deaf Youth Leadership Camp in Florida has decided not to go this year. She may try to go next year.

President Burdette stated that he still has not heard from Marty Blakely concerning whether or not there is a need for a computer in the Junior B Senior High School dorm at WVSD.

A check for \$100 Charles Weiner Award will be sent to Linda Phillips for graduating from Gallaudet University on May 14, 2004. A check for \$75 will be given to a WVSD Valedictorian and \$50 to a Salutatorian.

Reservations have been made for John Burdette and Jimmy Harrison to attend the NAD Conference in Kansas City on July 6-10, 2004. Reservations have been made for Linda Phillips to attend the retreat and NAD conference and pageant. Kara Russell has recently notified Linda and the board that she would not be able to go as a chaperone due to her job situation. We are now in the process of looking for a new chaperone.

President John Burdette received a letter from Suzanne Dennis, Silent Auction Coordinator for 2004 NAD Conference asking each State Association to donate a "theme" basket and the contents to be either shipped or brought to the conference. The baskets will be displayed in the Exhibit Hall as a Silent Auction activity. The conference attendees can try to win their basket of choice. 
John and Faye Deuel Celebrate their 50th Anniversary
