A regular board meeting of the West Virginia Association of the Deaf was held on February 27, 1999, at 1:40 p.m. at Cross Lanes Community Center in Cross Lanes,

Present were President, Jimmy Harrison, Vice-president, John Burdette, Secretary-Treasurer, Liz Purvis, and Trustee, Clyde Swartz.

The minutes from the December 5, 1998 WVAD board meeting were read and approved.

President's Report

1. Jimmy reported that he received a letter from Fairmont Association of the Deaf stating that they wanted to cancel their bid for the 2001 WVAD Conference.

2. Jimmy showed a new booster booklet designed by John Burdette. It will be used to write in names of people and businesses giving donation to the WVAD to help cover some expenses that will incur during the 32nd Biennial Conference.

1. Liz reported that she received some information on Deafywood Production Company from Donna Williams of Parkersburg to share

with the board members and other interested individuals.

Liz reported that she also received a copy of the letter sent to Donna Williams from National Captioning Institute (NCI) about the problem with missing captions on video tapes. The letter stated that if a video tape is purchased with a caption problem, the video company that makes copies should

send a replacement copy.

3. Liz reported that Donna has also sent a copy of the article, that was printed in the University Affiliated Center Developmental Disabilities newsletter, regarding the annual award named after the late Hubert Anderson. An annual award will be presented to an individual who has provided exemplary service to or advocacy on behalf of West Virginians with disabilities. The first 1998 Hubert Anderson Award was presented to Dr. Michael Valentine at the February WVATS Advisory Board Meeting.

Celebration of Deaf Culture

I went to Marshall University to give a presentation about deaf culture. I had been asked by Cheryl Cooper, Senior who is doing a project on "Celebration of Deaf Culture" lecture series. It was my first time visiting the campus of Marshall University.

Within my presentation of deaf culture I shared that it consists of history, values, language, education. technology, and tage/folklore the deaf

community.


For the language of the deaf, the major sign language used in the deaf community is American Sign Language (ASL). It's a visual language that relies heavily on facial expression and mouth movement, and body language. There are many different sign languages, but we mostly feel that ASL is our only natural language in form of communication. I also emphasized that eye contact is very important to the deaf people who are communicating with sign language. That is the reason "Eves are our Ears" to deaf people.

Identity is an important issue with the deaf community and individuals who are deaf due to setting of education, language, and whether their parents were deaf or hearing. It is important for anyone who is learning ASL to have a full understanding of ASL and deaf

culture

About assistive devices and technology, again I explained to them that most of the assistive devices are flashing devices and vibrations. Deaf people depend on their eyes and the feeling of

The 1998 Hubert Anderson Award Winner

An annual Hubert Anderson Award will be presented by the WVATS Advisory Board each December to an individual who has provided exemplary service to or advocacy on behalf of West disabilities. with Virginians Hubert Anderson was Executive Director of the WV Commission for the Deaf and Hard of Hearing and was serving in his second term as Chair of the WVATS Board at the time of his death in November 1997. The first annual award was presented to Michael Valentine. Ph.D., at the February WVATS Advisory Board Meeting.

Dr. Michael Valentine has worked in the field of education for nearly 30 years with a broad range of experience from public to higher education. He has been an instructor at Galluadet University, where he received his Ph.D., Marshall University, Salem State College, the University of Charleston, and the West Virginia College of Graduate Studies. His administrative background cludes experience at the Texas School for the Deaf, the West Virginia Division of Rehabilitation Services. the West Virginia Department of Health and the West Virginia Department of Education, he has served as coordinator of low-incidence programs, director of the Deaf-Blind Project, Director of Special Education and is now Assistant State Superintendent.

Dr. Valentine was one of the original authors of the Assistive Technology Systems Change Grant which resulted in WVATS. His enthusiastic support of assistive technology is clearly evidenced by his lobbying for continuing financial and technical assistance for the annual Paths Conference, Camp Gizmo, and various other training and educational opportunities for parents, teachers, and students in West Virginia

As a certified interpreter in West Virginia, Dr. Valentine is

frequently engaged in interpreting for major events in the state. He has hosted a weekly television public service program "Listen to Me" sponsored by the West Virginia Library Commission, Community Service Program for the Deaf.

Dr. Valentine has demonstrated exceptional leadership skills and a strong personal commitment to the education of students with disabilities in West Virginia. He has modeled personally and professionally a sensitivity to and a passion for assisting individuals with disabilities and is a fitting recipient of the first annual Hubert Anderson Award.

Many birds have already been killed after this product was used in any proximity to them whatsoever, and some dogs have also died. Other dogs have become ill without dving.

John Burdette (Clyde Swartz) moved that we table the Sympo until further information is received. Motion was carried.


Clyde Swartz (John Burdette) moved that the we close old business. Motion was carried.

Continued from page 1 vibrations. I described the difference between TTY and Relay Service and how it works. I told them that nowadays, technology makes much easier for deaf people with a Pager, Fax or Internet/Online to communicate with other deaf or hearing people without any communication barriers.

I shared information with them on how the deaf people keep up with each other in the deaf com-Socialization usually munity. takes place at deaf clubs, organizations, or special events. It is often that deaf people have a tendency to be late because they like to chat for long periods of time to share and catch up detailed information about their lives, family, friends, and the change in routine or expectation. It is a place where deaf communities are an extremely tight world that we all preserve friendship, interaction, also to create the political strength the deaf need to lobby for support from the larger community. there is a sporting event for the deaf, it can draw a large number of attendance from all over, not just for the sport but for the socialization.

Along with my presentation, I also shared several examples from my personal experiences during my childhood years and my years at Gallaudet University. I learned lot more at Gallaudet interacting with students across the US including the International Students. They bring their own sign language and culture to Gallaudet. It enriched my knowledge in foreign sign languages and the deaf culture in their native countries.
