Deaf since birth, Monica Rae Spangler, were born in Huntington, WV. She was 15 months old when her parents discovered she was deaf. She was fitted with a hearing aid and her mother started learning sign language to teach Monica. She attended mainstreamed classes at Meadows Elementary Beverly Hills Middle School, and Cabell Midland High School in Huntington, WV. She graduated from Cabell Midland High School on June 2001.

While at Cabell Midland High School, Monica participated in several organizations and won several awards. Her favorite organization the Child Care Academy for three years. It was an opportunity for her

to experience "job shadowing" at an elementary school where she went to classes with a 7-year-old deaf boy. She took several classes and visited day care programs, many elementary schools and hospitals. One project she did was to read a book about puppet Moose. Afterwards, she served apple juice and blueberry muffins.

She was also a peer tutor during her junior year. She worked with students in the Special Education program for mentally retarded and Down Syndrome by helping them with their class work, walking with them to lunch and helping them with lunch.

During her sophomore year, she was involved in a musical play--"Li'l Abner". She was one of the dancers on the dance team.

These experiences helped her to decide she wants to work with deaf children.

She was also a member of the National Honor Society and received a "Straight A's" Award and the Academic Excellence Awards. Other awards she received include Principles of Technology Award; All-Around Dedicated Learner Award: and the Quota International Outstanding Hearing Impaired Student Award.

This fall, she attends Eastern Kentucky University (EKU) to study Deaf Education. She hopes to get involved with the Kentucky School for the Deaf, which in 30

miles from EKU.

was held at 2:05 p.m.



### He has the shooter's touch

Archer overcomes handicaps for national honors

It seems that every sport has a feel-good story an athlete who's overcome a handicap or illness to succeed in his or her sport of choice.

Enter Robert Mackey of Cameron. Competing in the archery event at the West Virginia Senior Classic Friday, June 15, 2001 at Coonskin Park, Mackey qualified as an honest-to-goodness feel-good story.

The 73-year-old Mackey can neither hear nor speak due to diphtheria since he was a year old. But, communicating through exchanged notes, he said he didn't like to talk about his handicap. What he liked to talk about was archery, and his accomplishments in the sport.

"I finished seventh at the national senior games in Orlando, Fla., in 1999 and eighth at Tucson, Ariz., in 1995,' said Mackey, who competes in 70-74-year-old release class. "And I've finished first here [at the West Virginia Senior Games] six times. I also go to the Deaf Archery Tournament. I have many trophies and plaques."

Mackey, who considers himself a natural as an archer, picked up the sport at the West Pennsylvania School for the Deaf in Pittsburgh after his wife died 15 years ago. He said he instantly fell in love with it.

"After my wife died, a deaf friend told me to try and learn how to shoot," said Mackey. "He taught me and I picked it up very quickly. I loved it immediately."

His love is for the skill of the sport the competition only. He is a rare archer in that he doesn't use his skill to hunt animals.

"I don't want to shoot a deer," laughed Mackey, who also serves as vice president of the Wheeling Association of the Deaf.

Mackey, along with Robert Napier of Ottawa and Russ Shannon of Hampton, Va., were the only competitors at this year's event and went unopposed in their respective classes. Napier, who retired from Sharpels Coal Company in 1992, is the defending champion in the in 65-69-year-old fingers class and Shannon, competing in the 60-64 release class, is retired from the Air Force and was making his first appearance at the Senior Games.

# Deaf people are world's best drivers

Deaf people make better drivers than people with normal hearing and they could be the world's safest motorists, a fascinating new study shows.

"They've got it all over us hearing people when it comes to driving," said a spokesman for the National Association of Driver Educators for the Disabled.

"They've always taken in everything with their eyes and as a result they tend to see everything when they're at the wheel."

And not being able to hear ambulance and other emergency sirens doesn't make deaf drivers unsafe at all. The study found that deaf drivers check their rear-view mirrors frequently and can tell immediately if they should pull to the side of the road.

### **Dotson Signs** With Marshall University

Marshall University women's basketball head coach Rovce Chadwick announced on May 18 the signing of a phenomenal player to his arsenal.

Ida Dotson, 21, a two-time NJCAA Kodak All-American at Central Arizona College, signed with the West Virginia university after contemplating offers from other universities.

Dotson was the mainstay of a CAC team that went 61-7 during her freshman and sophomore seasons. Last season, her sophomore season, Dotson averaged 15.6 points, 4.4 rebounds, 3.1 assists and 3.0 steals per game. This earned her the Arizona College athletic Community Conference Player of the Year Award. As a freshman, Dotson averaged 15.4 points, 3.7 rebounds, 2.3 assists and 2.8 steals per game. She also earned All-American and All-Conference honors, as well as Freshman of the Year.

Dotson, who grew up in Tombstone, Ariz., is a product of the Arizona School for the Deaf Blind in Tucson and Tombstone High School. started to play basketball at the age of 6, and learned how to play from Jeremias Valencia," Dotson said.
"I played with the boys at ASDB and I fell in love with the sport."

"I first noticed Ida in 1999 as a freshman at Central Arizona," said Chadwick. "I watched her develop as a player and student athlete for two years. She is a legit big time college player."

When asked why she picked Marshall over a program where services would not be paralleled with those of other colleges that offer deaf programs or services. Dotson replied that she was looking for the right environment. "It's

always been my goal since I was little to play for a Division I school. I got a scholarship offer [Marshall], and I couldn't refuse it," said Dotson. " I went to junior college because I wanted to reach the Div. I level. I had to work hard to reach my goals."

Chadwick shares the same feelings Dotson does, and he looks forward to coaching her. believe Ida will have a huge impact on our team. We need a scoring threat from the shooting guard position, and we just added one of the best players in the country from the junior college ranks."

When asked about communicating with her hearing teammates, Dotson replied, "They will have to learn sign to communicate with me on court. Off court, it's up to them. I never had any problems at Central Arizona with my coach or teammates."

Dotson will also be representing the United States at the Summer Deaf World Games this summer in Rome, Italy. "My goal is to win a gold [medal] and to play well."
